### **17 – 09 – 077 Chair's Introduction**

*Conflicts of Interest*- The Chair requested members to declare any conflicts that they may have with the agenda items and reminded members to advise her of any conflicts that may arise during the course of the meeting.

### **17 – 09 – 078 Minutes of Plenary Meeting 20 & 21 June**

### **17 – 09– 080 Matters Arising**

*Aosdána*

Members were informed that the Chair of the Toscaireacht had been in touch with the Chair over the summer and that both Chairs were now due to meet however a meeting date has yet to be arranged.

#### *ARC Chair Appointment*

Members were informed that there was no further update at present on the matter.

#### **17 – 09– 081 Director’s Report**

##### *Memorandum of Understanding (MOU) with the Irish Research Council*

Members were informed that the MOU will guide partnership between the two agencies and provide for structured and consistent engagement over the period 2017 – 2020. Members asked that an expert panel on the arts needs to be established and noted that this agreement would help to progress research in this area. Members welcomed and **approved** the MOU.

##### *Festivals Update*

Members **noted** updates in relation to the Dublin Fringe Festival and Clonmel Junction Festival. Members also **noted** the update in relation to the Festival Investment Scheme Clinics.

Members **agreed** a budget 2018 increase to €1.4m for small festivals.

##### *Touring Forum Proposal*

Members were update on a proposed collaboration between Theatre Forum and the Association of Irish Stage Technicians to establish codes of practice that will help strengthen the working relationship between venues and producers. Members welcomed the recommendation and **agreed** to invest €9,500 in the initiative.

##### *Creative Schools- Project Lead Contract*

Members were informed that following the completion of an EU procurement process Creativity, Culture and Education (CCE) Limited have been selected as the project lead for Creative Schools. Members **approved** the contract term options and related budgets and **agreed** to their appointment. Members separately **noted** the daily rates quoted for additional services. Members **agreed** that a transparent approval process should be put in place to manage any additional work instructed under the contract.

Members **noted** that a full update on the Creative Schools Project will be brought to Council later in 2017.

##### *Tradition Now 2017 Update*

Members **noted** the Arts Council’s investment of €40k for 2017 with confirmation that the festival will take place from 3 - 8 October.

##### *New Music Dublin (NMD) Update*

Members were presented with 1) an indication of the Council’s approach to assessing the progress of the initiative particularly in terms of performance indicators, and 2) sight of comprehensive accounts/ and budget for NMD partnership to cover 2016/2017 financial years. Members **noted** both. Members separately highlighted the need for the 2018 NMD festival to be closely monitored by the executive specifically in terms of increased attendance figures.

### **17 – 09– 087 Appeals Panel- 11 September**

The recommendations from the Appeals Panel were as follows:-

Gabriel Rosenstock, Application Number: A273736, Irish Language Literature Bursary Award 2017, Round 2. Appeal Outcome-the appeal was not upheld. No failure in the process

Martin Tourish,, Application Number: A273306, Deis Recording and Publication Award, 2017. Appeal Outcome- appeal was upheld. The panel found that the assessment incorrectly used "Other Income" as the absolute criterion to determine feasibility. The panel recommended as a remedy that the application be presented at the shortlisted stage of the next appropriate award.

The recommendations of the Appeals Panel were **approved**.
