

Report on disability, ethnicity and gender in individual awards for 2021

About this report

The analysis in this report is based on diversity data submitted as part of applications made to the Arts Council and for Arts Council schemes managed by Create and Arts & Disability Ireland in the year 2021. The diversity of applications and awards are compared in terms of disability, ethnicity, gender, and where possible, geographic location. To understand the relative demographic representativeness of applicants and recipients, each of these metrics have been compared (where possible) to the population of Ireland Census 2016.

This report presents a summary of key findings from that analysis.

Context

In 2019 the Arts Council published its **Equality, Human Rights and Diversity Policy**, which included a three-year action plan (2019-2021). In the Artists' actions we have committed to collecting more information about the artists that apply for funding and those who receive funding. We have new systems in place to collect information about disability, ethnicity, and gender and have indicated that there will be:

- Reports provided to Policy & Strategy Committee of the Arts Council on statistical data.
- Report on statistics published on Arts Council website annually.

This report is the second annual report covering data collected during the 2021 calendar year. It provides details of all those who applied for and received funding across our Individual Awards (namely Bursaries, Agility Award, Next Generation, Liam O'Flynn Award, and the Markievicz Award). It additionally looks at applicants to specialist schemes operated on our behalf by third parties – the Artist in the Community Scheme managed by Create; and Arts and Disability Connect Scheme managed by Arts & Disability Ireland.

For the most part these awards are focused on the professional development of the artist, thus artists are the applicants and recipients. In some areas, however, the applicant may also be an arts professional in another area (e.g. manager, administrator). The emphasis in this report is on applications that will benefit individuals as opposed to organisations.

Notes on the data

A total of 6,218 records are included in the analysis (compared to 4,375 in 2020). These are broken down as follows:

Regarding response rates, note that 2% of applicants preferred not to answer questions on gender, 3% on ethnicity, and 6% on disability. While higher completion rates would be desirable, the proportions small enough that they are unlikely to affect the overall results.

Notes on analysis

The 2016 Census data does not include statistics on gender categories, only sex. Therefore where these figures have been included as a comparison, the findings should be considered indicative.

In this report County Dublin includes the four local authority administrative areas of Dublin City, Dún Laoghaire–Rathdown, Fingal and South Dublin.

Summary of Findings

Overall

That analysis looked at the extent to which the following were representative:

- the proportion of applications by group compared to the population
- the proportion of awards compared to the proportion of applications, and
- the value of awards compared to the proportion of applications.

Note: the term 'value', as used throughout this report, refers to the financial value of applications. Specifically, the 'value of applications' refers to the amount requested by applicants, while the 'value of awards' refers to the amount of funding applicants received.

The following differences are most pronounced:

Gender: There is a higher proportion of both applicants and recipients who identify as female compared to the general population. On average individuals who identify as non-binary apply for and are granted the highest award value.

Disability: Individuals who identify as having a disability are under-represented by half amongst applicants and recipients compared to the general population. On average, individuals who answered 'Yes' to having a disability apply for and are granted the lowest award value.

Ethnicity: The majority of applicants and recipients identified as White Irish, which is in line with the census 2016 data. The success rate for awards is also highest among applicants from White or White Irish backgrounds. The rate of application and award is lowest among individuals who identify as Other or Mixed, Asian or Asian Irish, Black or Black Irish, or belonging to the Traveller Community.

Geography: Dublin was significantly over-represented in terms of proportion of applicants and recipients compared to the population. Cork, Galway, Wicklow, Clare and Sligo were also slightly over-represented in applications.

There was substantial competition for these funding streams, with the following number and values of applications and awards:

Applications:

- 6,218 applications submitted during 2021
- Total value of applications during this period is €57,177,905
- Average value requested is €9,442

Awards:

- 2,474 awards
- Total value of awards during this period is €18,767,355
- Average value of award is €7,586

Gender




Figure 1: Application and award breakdown by gender

Amongst both applicants and recipients, individuals who identify as female are slightly over-represented compared to population statistics in the 2016 Census (fig 1)., while individuals who identify as male were under-represented (although these are not directly comparable, as the Census statistics relate to sex instead of gender).

When looking at the total value of applications made by female, male, and non-binary people, they are broadly proportional to the overall number of applications (fig 2).

- Individuals identifying as non-binary contribute to 2% of the total value of all applications vs 3% of the total value of awards.
- Female applicants contribute to 56% of the total value of all applications vs 59% of the total value of awards.
- Male applicants contribute to 40% of the total value of all applications compared to 36% of the total value of awards.

When comparing the overall value of awards female, male, and non-binary recipients are also represented in proportion to the overall number of awards granted.

However, when the average value of applications and awards are taken into consideration, on average, non-binary applicants tend to apply for higher amounts, which is then reflected in higher average value of awards granted. (fig. 3):

- The average value of applications made is higher for non-binary applicants (€10,691) compared female (€9,241) or male (€9,065) applicants.
- The average value of awards granted is also higher for non-binary applicants (€9,177), compared to female (€7,509) or male (€7,607) applicants.



Disability

Overall, both applicants and recipients who identify as having a disability are underrepresented when compared to the population of Ireland as recorded in the 2016 Census.

 Individuals who identify as having a disability are half as prominent amongst applicants (7%) as compared to the census (14%; fig 4).

When looking at the total value of applications:

 Applications made by individuals who identify as having a disability comprise 6% of the total value of applications vs 6% of the total value of awards (fig 5).

- The average value of applications made by individuals identifying as having a disability is lower than individuals who do not (€8,468 vs €9,225) (fig 6).
- The average value of awards granted to individuals who identify as having a disability is similar to applicants who do not identify as having a disability (€7,426 vs €7,578).
 The gap has narrowed since the last report published in 2021.

Arts and Disability Connect scheme

A total of €116,091 has been distributed through this scheme to all applicants who identify as having a disability (this accounted for 10% of the total value of awards to recipients with a disability: €1,210,498 overall).

Female applicants who identify as having a disability were granted the highest values, followed by male applicants, and then non-binary applicants under this scheme.

Ethnicity

Individuals from a white background were disproportionately represented in both applicants and recipients of awards.

White or White Irish background applicants made up 91% of applications and 92% of awards. When compared to the population of Ireland, as seen in the 2016 Census, this is proportionally similar to the national profile. However, Irish Traveller (0.4%) and Asian or Asian Irish (1.3%) are under-represented in the application profile compared to the Census (fig 7).

- Applications made by individuals who identify as White Irish contribute to 80% of the total value of applications and 80% of the total value of awards.


Figure 8: Average value by ethnicity

- The average value of applications from the White Irish community is €9,223, whilst the average value of awards is €7,626 (fig 8).
- The highest average value of applications is from individuals who identify as Other or Mixed ethnicity (€10,717), whilst the average award value granted to them is €7,340.
- The highest average award value granted is to individuals who identify as belonging to the Irish Traveller community at €12,688.

When comparing success rates across different ethnic groups, the highest is among applicants from White or White Irish backgrounds with 91% of applications resulting in an award. All other ethnic backgrounds have a proportionally low success rate, which is circa 1% across the board for all Other or Mixed, Asian or Asian Irish, and Black or Black Irish (fig. 9).

County Dublin received the highest number of applications and awards from individuals who identify as Other or Mixed, Asian or Asian Irish, and Black or Black Irish.

Geography

In 2021 the three most prominent counties, in terms of both applications and awards, were: Dublin¹, Cork and Galway. More specifically, 58% of all applications and 61% of all awards came from one of these three counties.

- The highest proportion of applications and awards originate from County Dublin, making up 39% of all applications and 42% of all awards. This is an overrepresentation compared to the proportion of the population of Ireland who live in County Dublin (28%, fig. 10).
- Applications from County Dublin make up 39% of the total value of applications and 42% of the total value of awards.
- The average value of applications from Dublin is €9,210, whilst the average value of awards is €7,727.

Dublin is the county most over-represented in terms of the proportion of applicants compared to the proportion of the population. Cork, Galway, Wicklow, Clare and Sligo are also slightly over-represented, while the remaining 20 counties are under-represented.

When comparing the percentage of awards to the percentage of applications, 6 counties are over-represented (including Dublin, Cork, Galway, Wicklow, Limerick and Tipperary), while 20 are under-represented.
